a. Fiscal Year Proposed Budget 2023-24 (Water & Wastewater)

Minutes:

Finance Director Aaron Felmlee and Council discussed the proposed budget. PUBLIC COMMENTS: Sue Long, Wendt Construction - Expressed concern for building fees increasing while the level of service declined. She expressed concerns with the new building software not improving the actual efficiency of staff in the department. She commented that if the software does prove to increased efficiency in permit processing in the near future, she would commend the Council and City Manager at that time, but expressed doubt of that actually happening. She felt that until efficiency improved, it was wrong to increase fees. She also expressed frustration that the Council was considering

approving the increase to building fees with the passing of the Fiscal Year 2023-24 budget. In regards to Parks and Recreation fee increases, she pointed out that the \$15,000 annual fees for park and field maintenance would be a cost even if there were not sport user groups using the fields.

Matt Eberhardt - Fortuna Resident - spoke in support of holding a workshop for the Council to discuss building fees.
